1. New regulations on the implementation of the Labour Code

On 12 January 2015, the Government issued Decree No. 05/2015/ND-CP, detailing and providing guidelines for the implementation of a number of contents of the Labour Code ("Decree 05").

This Decree provides for rights and responsibilities of employers, employees, organizations representing employees, agencies, organizations, individuals related to the implementation of a number of provisions of the Labour Code with respect to labour contract, collective bargain, collective labour agreement, wage, labour discipline, material responsibilities and settlement of labour disputes.

The working period used for the calculation of severance allowance or jobloss allowance is the total period during which the employee actually worked for the employer minus the period during which the employee has participated in the unemployment insurance in accordance with the law and the working period for which the employee has received severance allowance from the employer.

In some special circumstances, severance allowance and job-loss allowance are particularly specified as follows: In case where an employee who has actually worked for an employer for 12 months or longer loses his/her job, while the working period used for the calculation of job-loss allowance is less than 18 months, the employer will have to pay the employee a job-loss allowance of at least equal to 02-month-wages; In case where the employer terminates the labour contract after the merger, consolidation, division and separation of the enterprise, the employer is responsible for paying the employee a severance allowance or a job-loss allowance for the period during which the employee has worked for the employer and the period during which the employee has worked for the previous employer prior to the merger, consolidation, division and separation of the enterprise or cooperative.

In addition, Decree 05 also stipulates the principles of wage payment as follows: An employee must be paid with a full wage in a direct and timely manner; In special cases in which an employer cannot timely pay an employee's wage as agreed in the labour contract due to natural calamity, fire or other force majeure reasons though having applied every remedial measure, the employer must not postpone the payment for more than 01 month.

Employees enjoying wages based on time must be paid wages for overtime work for time worked in addition to normal working hours stipulated by the employer in accordance with Article 104 of the Labour Code; Employees enjoying wages based on products must be paid wages for overtime work for time worked in addition to normal working hours to produce more quantities and volumes of products and work in addition to the quantities and volumes of products and work according to the labour norms agreed with the employer.

Wage for overtime work is calculated according to the wage unit or wage for the employee's current job as follows: On normal days, at least equal to 150%; In weekends, at least equal to 200%; On public holidays and paid leave days, at least equal to 300%, excluding the wage for public holidays and paid leave days of employees who receive daily wages under the Labour Code's provisions.

This Decree shall take effect on 1 March 2015.

2. New regulation on the business and supply of interest rate derivatives of commercial banks and foreign banks' branches

On 6 January 2015, the Governor of the State Bank of Vietnam issued Circular No. 01/2015/TT-NHNN, providing for the business and supply of interest rate derivatives of commercial banks and foreign bank branches, replacing Decision No. 62/2006/QD-NHNN promulgating the regulation on execution of interest-rate swap transactions ("Circular 01").

Circular 01, consisting of 4 Chapters, 22 Articles, is applied to commercial banks ("banks") and foreign banks' branches carrying out the business and supply of interest rate derivatives; customers using interest rate derivatives, including credit institutions ("CI"), branches of foreign banks established and operating under the Law on Credit Institutions, and legal entities (other than CI and foreign banks' branches) established and operated under Vietnam's laws; organizations and individuals involved in business and supply activities of interest rate derivatives of banks and foreign banks' branches.

The new Circular provides for the business and supply activities of interest rate derivatives on the domestic market and business activities of interest rate derivatives on the international market.

Also, Circular 01 provides for the limitation of the business, supply and use of interest rate derivatives; interest rate, interest rate derivative contract and records of business and supply activities of interest rate derivatives; risk prevention provisions, accounting and reporting.

In addition, the new Circular also specifies the responsibilities of banks and foreign banks' branches carrying out the business and supply of interest rate derivatives and customers using interest rate derivatives.

This Circular shall take effect on 2 March 2015.
