LAW ON ENTERPRISES

Would Decree 90 bring supports to issuers of corporate bonds?

As you may know that Decree 90 was issued by the Government of Vietnam on 14 October 2011, which will take full effect from 01 December 2011, and replace entirely Decree 52 on on-shore issuances and part of Decree 53 in connection with off-shore issuances, of corporate bonds by companies in Vietnam. As clearly set out in its Article 3, the intended purpose of Decree 90 is to provide supports to companies in Vietnam and make them in a better financial position to (A) realise their investment projects, (B) increase the size of their capital, and (C) have a more flexibility in re-structure of their debts.

Decree 90 introduced a number of new provisions regarding not only on-shore issuance but also off-shore issuance of corporate bonds by companies in Vietnam. However, this article intends to talk only about new provisions regarding only on-shore issuances in a comparison with Decree 52, with necessary comments.

- 1. Who is entitled to issue corporate bonds. For the first time, Decree 90 confirmed clearly that limited liability companies (each, "LLC") will be entitled to issue unconvertible corporate bonds, in and outside Vietnam. This would definitely help ending discussions in the recent time on whether a LLC has that right under Decree 52.
- 2. <u>Basic principles for an issuance</u>. In addition to other principles as also required by Decree 52 (e.g. self-borrowing, self-payment, etc.), Decree 90 introduced a new principle which requires an issuer to contribute and retain at least 20% of the total investment capital of an investment project in case it intends to issue corporate bonds domestically for the said project. Amongst all, this may need to disqualify incapable issuers from the market, but in some cases, it may challenge some others and limit the chance for them (particularly new companies with good projects) to have an access to the capital market.
- 3. <u>Basic conditions for an issuance</u>. The conditions for an issuance are basically the same as what were required by Decree 52. However, Decree 90 tended to make each of them clearer (to some extents) and stricter (in most cases) if compared with the same as required by Decree 52. *With respect to an issuance of unconvertible bonds*, to be qualified for an issuance, an issuer must be profitable, which is evidenced by the latest audited financial statements. Amongst all, the point which Decree 90 tended to make it clearer here is that the said audited financial statements must be the one fully accepted by the auditors, without any exceptions. *With respect to an issuance of convertible bonds*, Decree strictly requires that the time between the two issuances (i.e. after the completion date of the previous one and before the issuance date of the following one) must be at least six months, and that in all cases, the foreign ownership in the issuance company must not exceed the ceiling limits as provided by the securities laws (e.g. 49% with respect to the listed companies). That would be fine if the said ceiling limits will be applicable from the time the convertible bonds are

converted into shares. However, it would be inappropriate if Decree 90 intended to apply the said ceiling limits immediately from the time the convertible bonds are issued, and this may unnecessarily limit the change for companies in Vietnam on its access to foreign capital.

- 4. Bond term and lock-up period. For the first time, Decree 90 confirmed clearly that the term of a corporate bond must be at least one year or over. It means that any corporate bond of less than one year term (which was permissible under Decree 52) will not be permitted to be issued in Vietnam, after 01 December 2011. In addition to that, convertible bonds or securities rights attached to a corporate bond will only be permitted to be transferred after at least one year from the issuance date. Amongst all, there would have some grounds for this lock-up provision, but in general it may limit the chance for companies in Vietnam to issue bonds of this type for the purpose of re-structuring their debts (one of the purposes of Decree 90), and at the same time challenge the liquidity of the new bond markets, in Vietnam.
- 5. Who has the power to approve an issuance. Decree 90 clearly provided that with respect to convertible bonds or securities rights attached to bonds, only general shareholder meeting ("GSM") will be entitled to approve, and that with respect to unconvertible bonds, the decision maker can be either the GSM or the board of directors (with respect to the joint stock companies) or the members' council or the company president (with respect to the LLCs).
- 6. Public disclosure and report on an issuance. Decree 90 introduced some new rules on public disclosure and report, and clearly provided the time when each of them must be done (i.e. before and after an issuance), which were mostly silent by Decree 52. However, they are all much stricter than those were provided by Decree 52. Before an issuance, an issuer will newly be required to notify the Ministry of Finance ("MoF") of its intended issuance. As Decree 90 added that the MoF will make a detailed guidance on the notification and registration, it is unclear now whether this requirement will be applicable only to state-owned companies or it will be extendible also to all types of companies, including nonstate private and public companies. It is seen that this requirement would be fine with respect to state-owned companies as the MoF acts as a state owner representative and it may be necessary for its state management in the market, but it may unnecessarily cost time and money for all other parties in the market if looking at it from the commercial perspective. In addition to that, Decree 90 required specifically that public companies will be required to register their intended issuances with the State Securities Commission ("SSC") and the issuances will only be made after the approvals of the SSC. Another new thing is that the issuer after the said notification to the MoF, will be required to make an announcement of its issuance to potential investors in the market. However, the condition for that will be that an announcement for a private issuance will not be permitted to make on any mass media or in the way that it looks like a public offer. After the issuance, the issuer must within 15 days from the completion date, make another announcement of the issuance results (with respect to a public company, it must do so in compliance with the securities law), and at the same time make a report on the issuance results to the competent bodies which have approved the issuance plan, with a copy submitted to the MoF.

7. Report on the use of proceedings and repayment. For the first time, Decree 90 set out the new rules for all issuers (regardless they are private or public, state owned or non-state owned companies) to make their reports, after the issuance. This was mostly silent under Decree 52. Pursuant to the new rules, during the term of the issued bonds, the issuers must have their reports, on annual basis, on the use of proceedings from the issuance and the repayment, and then submitted to the competent bodies which have approved the issuance plan, with a copy submitted to the MoF. In addition to that, within 15 days from the maturity date of the issued bonds, the issuers will be further required to make a report, on the repayment status, and then submitted to their competent bodies which have approved the issuance plan, with a copy submitted to the MoF. With respect to convertible bonds or securities right attached to the bonds, within 10 days from the date of completion of the conversion, the issuers will be required to make another report on the conversion of convertible bonds or securities right attached to the bonds, and then submitted it to the competent bodies which have approved the issuance plan, with a copy submitted to the MoF. Amongst all, it would be fine if the new rules will apply only to state owned companies, but it seems inappropriate if the new rules will apply also to non-state owned companies as this interferes deeply in their ordinary course of business and limits the business autonomous rights that the Enterprise law provides to all companies.

Acknowledging the lesson learnt from the recent implementation of Decree 01 (on the private issuance of corporate shares which was issued on 04 January 2010), it is expected that the provisions of Decree 90 will be translated into practice by all relevant parties, particularly the competent authorities (i.e. the MoF, the SSC, the SBV, and business registration system), in the way that provide most supports to companies in Vietnam on their way to get a wider access to the capital market, particularly in the current context of the global and national economies' difficulties, and that the MoF will soon issue its detailed guidance on the notification and registration by the companies before their issuances, as well as the preparation and submission of different reports during the term of the issued bonds./.
